These Terms, Conditions, and Guidelines are applicable to and govern the "IHW Awards" organized and conducted by Integrated Health & Wellbeing Council

- By participating in the Awards, Participant agrees to abide by and be bound by these Terms.
- These Terms may be modified without any prior notification. A participant is advised to regularly review these Terms. If there is any disagreement with any of the Terms and any amendments thereto, Participant must not participate or withdraw application from the Awards.

Eligibility Criteria for participation in the Awards

- Any organization/institute participating in the Awards should be an Indian entity with a registered presence in India and must provide their Certificate of Incorporation mandatorily
- The initiative should have been completely executed in India

- There are no minimum years of operations applicable for organizations participating, however the Certificate of Incorporation is a mandatory document to be submitted
- The initiative/ project should have been launched in the period April 01, 2021 to March 31,2022 with impact demonstrated and results showcased by initiative/ project in the period April 01, 2022 to March 31, 2023
- The initiative must be undertaken by going beyond the mandatory accreditations/regulatoryrequirements as applicable
- For Start-ups, the organization must have been incorporated for up to 5 years as on March 31,2023.
- The initiative nominated/ applied must be developed within the participating Organization. An Organisation cannot participate on behalf of its sister units; parent organization or other organizations under the parent organization
- The Applicant should not be a winner of the Award in any of the previous years for the same initiative/innovation
- The final eligibility of the Participant will be subject to the discretion and approval of the Awards Management and Jury
- The Award categories may be changed/modified / split / merged/increased or cancelled by the Awards Management and/or Jury based on the number of entries received in any category, and the quality of the entries. The decision in this regard will be final, non- contestable, and binding on all participants. The Awards management will not entertain any queries in this regard

NOTE – The Jury holds the right to disqualify any application which does not meet the eligibility criteria without assigning any reason whatsoever

Call for Entries & Participation

- The call for entries for the Awards will be announced in one or more media platforms and / or by direct communication, and that shall be construed to be adequate notice for call for entries
- Participants can apply for the Awards by completing the application form online
- Link to fill out the application form will be available on the website https://www.ihwcouncil.org/digitalhealthsummit
- Participant needs to duly fill in all information points on the Application Form
- Participants can have multiple entries in multiple categories
- The Awards management has the right to reclassify application form/forms from one prize category to another, at their discretion

Completeness of Entries/ Disqualifications

- All mandatory fields of the application form need to be complete in all respects; else it may be disqualified from participation.
- Applicants can apply only once for an initiative /project in a respective category. A separate the form must be used for every new entry.
- Entries will be accepted in English language only
- Up to 5 supporting material such as photos, articles, awards and accolades and other material can be submitted for each entry on a non-returnable basis (Any video submitted should be in the form of a YouTube link only)

- Disqualification of entries is at the sole discretion of the jury, on a case-by-case basis. The said disqualification will be as per the rules and regulations defined for the awards.
- If at any time, any information provided by an applicant is found to be incorrect in any manner, then the applicant will be disqualified from the awards
- If after the conclusion of the awards ceremony, any information provided by any applicant is found to be incorrect in any manner, then the applicant will be liable to return the award and the nomination fee will be non-refundable.
- Determination of whether the information provided by the applicant is incorrect or not is at the jury's discretion
- The jury has the right to ask for documentary proof of information provided/ audit the information provided. If such a request is made and the applicant does not comply within 3 days from the date the request is made, the applicant would be disqualified from the awards

Judging Criteria

- IHW Awards 2024 platform would cater to various categories for companies, organisations and individuals to nominate their initiatives, projects, products and ideas for the acknowledgement and rewards.
- The eminent Jury of the Awards would evaluate the screened entries and propose to announce the final winners in various selected categories.
- We will be giving out Gold, Silver, and Bronze awards in each category. Our expert panel will evaluate entries using a scale of 1 to 10 points, focusing on Project Ideas/Work done, Impact, and Scalability.
- Gold awards will go to those who score 81% and above score.
- Silver awards will be given to those who score between 66% and 80%.
- Bronze awards will be given to those who score between 50% and 65%.

Validity and Correctness of Information

- If at any time, including after the conclusion of any of the Award ceremonies, any
 information provided by any Participant(s), is found to be incorrect in any manner,
 then the Participant will be liable to be disqualified and / or return the Award and the
 monetary emoluments provided to the Participant under this Award, if any. Awards
 Management may also take penal action against the Participant for providing false
 information to participate in the Awards
- Determination of whether information provided as fair and accurate rests with the Jury and Awards Management
- Awards Management will make calls to the references provided in the application form for verifying the information provided by the applicants in the form

<u>General</u>

- Participant agrees that the Participant is legally capable of entering and, if selected, participating in the Awards and agree to the Terms.
- Participant understands and agrees that merely participating in this Awards does not entitle the Participant to a prize or to any other form of consideration

- Participant shall be completely responsible for handling any infringement or alleged infringement and shall indemnify Awards Management from any claims, costs or damages from infringement or alleged infringement of the logo or trademark or the defines of a claim or any costs payable thereof.
- Participants for the purpose of entering the Awards, automatically grants Awards Management a royalty-free, irrevocable, worldwide, non-transferable, nonexclusive right and license to use and display such entry, for participation in the Awards, and any intellectual property in relation to and arising out of such participation in the Awards and
- footage thereof, which shall include trade publications, press releases, electronic posting to the Website, the website in any display format selected during the Awards as it deems fit.
- The Awards Management reserves the right to, at its discretion, withdraw or amend or add to the T&C of the Awards at any time, with prospective or retrospective effect, and does not take responsibility for any loss or damage that any individual or organization may suffer as a result of participating or attempting to participate in the Awards, the Awards being withdrawn or its Terms amended.
- Should a Participant wish to withdraw from the Awards, kindly inform Awards management in writing (secretariat@ihwcouncil.org) at any time up to one week prior to the final awards ceremony, in this case, the nomination fee will be non-refundable
- All disputes relating to or arising out of the Awards shall be subject to the laws of India, and shall be subject to the exclusive jurisdiction of the courts of competent jurisdiction at Mumbai, India
- In the event these Terms do not cover any question or complaint in relation to the Awards, the same will be concluded on by the Awards Management (for all other issues) or an independent body or legal team as appointed by the Awards Management and deemed necessary
